If you cannot find a fully published version of the article that includes this information, you can cite the article as an advanced online publication, noting its status where you would usually include the volume, issue, and page numbers.

For an in-text APA journal citation that is not a direct quote, or an APA parenthetical citation, all you need to provide is the author's last name and the year of publication. You may provide a page number (preceded by "p." for one page or "pp." for multiple pages) as well if the passage or idea you are paraphrasing is on a certain page or set of pages, but this is not necessary for ...

When creating an in-text citation of a source with multiple publication dates using APA format, use the original date of publication, a slash and the cited edition's date. Example: (1946/2014). For an APA reference list, include "Original work published" and the original publication year in parentheses at the conclusion of the citation, with no other punctuation.

How to Cite a Source With Multiple Publication Dates ...

If a journal article has a DOI, include the DOI in the reference. Always include the issue number for a journal article. If the journal article does not have a DOI and is from an academic research database, end the reference after the page range (for an explanation of why, see the database information page). The reference in this case is the same as for a print journal article.

Journal Article References - APA Style

Articles With Two Authors . If an article has two authors, follow the basic format for a journal reference. Place a comma after the first initial of the first author followed by an ampersand (&). Then include the last name and first initial of the second author.

Other NEW Important Information in APA, 7th edition: All journal articles will include the issue number. Regardless, of whether or not the journal is continuously paginated. All articles coming from an academic database should be treated as a print journal. If the article has a DOI, include the DOI at the end of the reference.

For journal articles, these are replaced with the journal title, volume number, issue number and page number. The basic structure is: Journal Article
